Concern was raised about budget concerns (\$50,000 is allocated in the budget yearly for town hall needs) Discussion held, decided to see if grants are available for project and will review at next meeting. Questions were asked concerning time line of current ceiling project. The project contract runs until Oct. 31sr,2022.

The office ceiling work will begin next week. The office needs to be cleared out by then. Volunteers are needed. Kip and Joanna will put up hooks to hang banners on the outside of the building for events. Alicia will get quotes for resealing and painting parking lot for next meeting.

Fire Report Dale reported that new equipment is coming. Next years cost will be \$72,000 to the township fire coverage.

Road Report Township ditch mowing has begun. Barry will compile a list of blowdown trees that pose hazards in the ditch that need removing. Motion by Don and seconded by Harrison to have Bro Mowing remove and dispose of the trees for \$125/hour. All approved. Don will contact Gary Skime to put a 18 in culvert on 470th St.

Proposed levy for 2023 reviewed and approved by all. Copy sent to auditor.

August 24th zoom meeting for District 11 information shared with board.

Joanna and Harrison will attend legal meeting September 10th.

Kip will repair broken board on entryway.

Zoom meeting set up Work will be done for set up when hall is ready to be used and is cleaned.

Nary Park payoff notice of \$50,000 reviewed by board. Loan is now complete.
